The GAP consists of 12 members, the majority of whom are people with disabilities, nominated by international and regional networks of Disabled Persons Organizations, which makes grantmaking strategy recommendations. The Grantmaking Committee of the Board are composed of donor representatives and advisors and finalize recommendations on grantmaking strategy and guidelines and select grantees. The Boards of Directors have oversight of the Fund.
