In 2006, she was awarded a Ford Foundation International Fellowship. She also received the International Advocate Award from the United States International Council on Disabilities (USCID) in 2017. She is also the first Indonesian to have been a member of the Committee of the UN CRPD for the period 2019 -2022.
